- 5. Project updates
  - Solar contract— New contract with Encore under legal review, plan to present to SB May 14.
  - o EV grant—Submitted on April 30. For two charging stations.
  - Paving—Question has arisen whether base coat and top coat at same time or base coat followed by top coat at later date. Town is considering options. Stormwater trenching, took 11 readings, all came up at 0 for contamination.

#### Fritz arrives 2:08

- o Paths—Paul needs to be notified.
- Art—A funding possibility has arisen. Alice thinks it is pretty short notice to arrange for art purchases. Jerry thinks it is a good long-term plan. Ruth thinks the Town should consider establishing an Art in Public Places program with the Library as anchor but is concerned about insurance short term. Kevin has thought of leasing art through BCA; Ann thinks that BCA is great but you don't own anything after spending the money. Cathy will consider how to move ahead, perhaps the Trustees should take up this idea.
