I understand that if the stormwater system is not properly maintained, if Best Management Practices (BMPs) are no longer performed, or if the SSU determines in its sole discretion that the property no longer complies with the terms and conditions of the applicable NPDES permit for any reason, that the SSU can eliminate the credit awarded as part of this application.

I understand that once credit is awarded as part of this application that I am responsible for sending annual reports and copies of new or re-issued permits to the SSU. Failure to provide this information could result in loss of the credit awarded as part of this application.
