

TOWN OF SHELBURNE AUTOMATIC WATER/SEWER PAYMENT PROGRAM

The Town of Shelburne is pleased to offer the convenience of Automatic Tax Payments to Town property owners.

Under this program, your water/sewer/stormwater payments are automatically deducted on each due date from the bank account you specify. This assures timely payments, saves you time and eliminates the possible loss of the payment in the mail.

The electronic payments can be deducted from your checking, money market, or statement savings account and will be reflected on your bank statement.

To take advantage of this service, please complete the enrollment form on the following page and return it to the attention of BettyJean Bogue at the address shown.

Please note that once this service is started, it will continue for future payments until you notify us otherwise. If you wish to discontinue this service or make any changes to the bank information, we will need to receive this notification no later than 7 days prior to the due date to make changes.

Unless we hear differently, we will continue to deduct property tax payments from your bank account on each due date. If you sell your property or if a mortgage company will be paying your taxes, please notify us to discontinue the automatic payment for your account.

If there are insufficient funds in the bank account, the account is closed, or the bank routing/account number are not valid on the withdrawal date, we will not be able to apply a payment to your account. If this happens, the installment due on that date will be considered unpaid and subject to late penalty and interest charges.
